

CONTRACT FOR SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This **Contract for Services** ("Contract") is entered into by and between the following:

DEPARTMENT OF JUSTICE - PAROLE AND PROBATION ADMINISTRATION, a government agency created by virtue of the laws of the Philippines, with principal office address located at DOJ Agencies Building, NIA Road corner East Avenue, Diliman, Quezon City, represented herein by its Administrator, **MANUEL G. CO** (hereinafter referred to as "DOJ-PPA");

-and-

ZERO PEST CONTROL SERVICES, a single proprietorship created and existing by virtue of the laws of the Philippines, located at 345 April Street, Congressional North, Quezon City, represented herein by its General Manager, **DOMINIC REYES** (hereinafter referred to as "SUPPLIER");

WITNESSETH:

WHEREAS, DOJ-PPA canvassed through shopping for Pest Control Inspection and Maintenance Services for calendar year 2017 (hereinafter referred to as "Goods and Services");

WHEREAS, the SUPPLIER submitted its bid and is willing to enter into an agreement with DOJ-PPA;

WHEREAS, DOJ-PPA has accepted the bid of the SUPPLIER;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

1. Scope of Work - The SUPPLIER shall provide **Pest Control for DOJ Agencies Building (Ground, Mezzanine, Second and Third Floors) for calendar year 2017.**

In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Quotation and Job Description.

2. The SUPPLIER's Quotation and Job Description shall form and be read and construed as part of this Contract. A copy of the SUPPLIER's Quotation and Job Description is attached hereto as Annex "A".
3. For the services to be rendered by the SUPPLIER under this Contract, DOJ-PPA agrees to pay the SUPPLIER the following amount per treatment:






