INVITATION TO BID FOR
Provision of Security Services in the Parole and Probation Administration –
Central Office three (3) guards for Calendar Year 2018

1. The Parole and Probation Administration-Central Office, through the authorized appropriations under the FY 2018 General Appropriations Act,² intends to apply the sum of ***Nine Hundred Forty One Thousand Two Hundred Eight Pesos (Php941,208.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for Provision of Security Services in the Parole and Probation Administration-Central Office for CY 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Parole and Probation Administration—Central Office now invites bids for manpower services.³ The duration of the contract is from January 1, 2018 until December 31, 2018. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the address given below and inspect the Bidding Documents at the address given below during office hours.

5. A complete set of Bidding Documents may be acquired by interested Bidders starting on November 7, 2017 up to November 29, 2017 at the General Services Section, 2nd Floor, DOJ Agencies Building, NIA Road corner East Avenue, Diliman, Quezon City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (Php1,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Parole and Probation Administration, provided that the Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

6. The Parole and Probation Administration – Central Office will hold a Pre-Bid Conference⁴ on **November 17, 2017 at 2:00 P.M. at DOJ—PPA Multi-Purpose Hall, 3rd Floor, DOJ Agencies Building, NIA Road corner East Avenue, Diliman, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 29, 2017 at 1:30 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on November 29, 2017, 2:00 P.M. at the DOJ—PPA Multi-Purpose Hall 3rd Floor, DOJ Agencies Building, NIA Road corner East Avenue, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


9. The Parole and Probation Administration—Central Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time
