INVITATION TO BID FOR Supply and Delivery of Printing Equipment Requirements for the Automation of Performance Monitoring and Evaluation System

The Parole and Probation Administration-Central Office, through the authorized appropriations under the FY 2020 General Appropriations Act intends to apply the sum of One Million Three Hundred Five Thousand Six Hundred Pesos Only (Php 1,305,600.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply, and Delivery of Printing Equipment Requirements for the Automation of Performance Monitoring and Evaluation System. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Parole and Probation Administration-Central Office now invites bids for the Supply, Delivery and Installation of Hardware and Software Requirements for the Automation of Performance Monitoring and Evaluation System. Delivery of the Goods is required within sixty (60) days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

- 1. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 2. Interested bidders may obtain further information from the address given below and inspect the Bidding Documents at the address given below during office hours.
- **3.** A complete set of Bidding Documents may be acquired by interested December 03 to 23, 2019 from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount* of *Five Thousand Pesos (Php5,000.00) in cash, non-refundable.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 4. The *Parole and Probation Administration-Central Office* will hold a Pre-Bid Conference on *December 11, 2019, Wednesday 10:00 AM.* at the PPA Multi-Purpose Hall 3rd Floor, DOJ Agencies Bldg., NIA Road corner East Avenue, Diliman, Quezon City which shall be open to prospective bidders.
- 5. Bids must be duly received by the BAC Secretariat at the address below on or before *December 23, 2019 Monday 9:30 AM.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *December 23, 2019 Monday 10:00 AM.* at the PPA Multi-Purpose Hall 3rd Floor, DOJ Agencies Bldg., NIA Road corner East Avenue, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
