INVITATION TO BID FOR Supply, Delivery and Installation of Information and Communications Technology (ICT) Equipment for the Enhancement of Information Systems

1. The *Parole and Probation Administration – Central Office* , through the *authorized appropriations under the FY 2021 National Expenditure Program* intends to apply the sum of ***Thirty-Six Million Two Hundred Sixty One Thousand Pesos Only (Php 36,261,000.00)*** being the ABC to payments under the contract for ***Supply, Delivery and Installation of Information and Communication Technology (ICT) Equipment for the Enhancement of Information System with Public Bidding No. 2020-014*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
 - i. The *Parole and Probation Administration – Central Office*, through the *authorized appropriations under the FY 2021 National Expenditure Program* intends to apply the sum of ***Thirty-Six Million Two Hundred Sixty-One Thousand Pesos Only (Php 36,261,000.00)*** being the ABC to payments under the contract for ***Supply, Delivery and Installation of Information and Communication Technology (ICT) Equipment for the Enhancement of Information System with Public Bidding No. 2020-014***. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
 - a. The *Parole and Probation Administration – Central Office* now invites bids for the above Procurement Project. Delivery of the Goods is required by ***Delivery of the Goods is required within sixty (60) calendar days upon receipt of Notice to Proceed***. Bidders should have completed, within *Two (2) years* from the date of submission and receipt of bids, a contract similar to **Any contract of ICT Equipment**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

3. Prospective Bidders may obtain further information and inspect the Bidding Documents at the address given below during *office hours*.
4. A complete set of Bidding Documents may be acquired by interested Bidders on *November 26 to December 16, 2020* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (Php25,000.00) in cash, non-refundable.*** The Procuring Entity shall allow the bidder to present its proof of payment for the fees *it will be presented in person*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The *Parole and Probation Administration – Central Office* will hold a Pre-Bid Conference on **December 04, 2020; Friday; 10:00 AM** at *Multi-purpose Hall 3rd Floor, DOJ Agencies Bldg., NIA Road corner East Avenue, Diliman Quezon City*, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **December 16, 2020; Wednesday, 09:30 AM** Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on **December 16, 2020; Wednesday, 10:00 AM** at the given address below *PPA Multi-purpose Hall 3rd Floor, DOJ Agencies Bldg., NIA Road corner East Avenue, Diliman Quezon City* and Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
