THIS AGREEMENT is made by and between:

WHEREAS, DOJ-PPA conducted *public bidding* for the Project, "*Supply, Delivery and Installation of Communications Network for the Upgrade of the Server Facility and Local Area Network,*" and the bid of the SUPPLIER in the amount of **Nine Million Eight Hundred Ninety-Five Thousand Pesos (Php9,895,000.00),** hereinafter called the "CONTRACT PRICE", was determined to be the Single Calculated and Responsive Bid;

WHEREAS, the Notice of Award was issued to the Supplier on 24 February 2021 and the SUPPLIER posted its Performance Security on 02 March 2021;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract referred to in the Bidding Document;
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Bidding Document (Annex "A");
 - b. Winning bidder's bid, including Eligibility Requirements, Technical and Financial Proposals, and all other documents and statements submitted by the bidder (Annex "B");
 - c. Performance Security (Annex "C")
 - d. Notice of Award of Contract (Annex "D").

Other documents referred to in Section 37.2.3 of the Implementing Rules of Republic Act No. 9184 shall likewise form part of this Contract.

3. In consideration of the payments to be made by the DOJ-PPA to the SUPPLIER, the SUPPLIER hereby covenants with DOJ-PPA to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
