This means that the company is one that has had their employees successfully trained by an authorized trainer in these test methods, attests to using these test methods, and has purchased the correct test equipment. In this regard, the company with technical staff trained in STMC can easily determine the authenticity of their toner cartridge. Thus, they can protect the company against non-authentic product.</p> <p>Leading brands of printers show that they are STMC certified. Thus, STMC certification requirement cannot be removed.</p>


May we respectfully request to make it "Supplier should provide list of Manufacturer's branches/service centers nationwide" because not all the bidder has branches or service centers
