INVITATION TO BID

1. The **PAROLE AND PROBATION ADMINISTRATION-CENTRAL OFFICE (PPA-CO)**, through the **FY 2022 General Appropriations Act** intends to apply the sum of **One Million Three Hundred Seven Thousand Pesos (Php1,307,000.00)** being the ABC to payments under the contract for **Supply, Delivery and Installation of ICT Software Subscription Requirements for the Renewal of the Support and Remote Server Management License for the Parole and Probation Case Management Information System** with Project ID No: **PPA2022-05**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **PPA-CO** now invites bids for the above Procurement Project. Delivery of the Goods is required within **ninety (90) calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary **“pass/fail”** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on **October 12 - November 3, 2022** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The bidder must present its Official Receipt as proof of payment for the fees to be presented before the bid opening.

It may also be downloaded free of charge from PhilGEPS website and the website of Procuring Entity, provided that the bidder shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **PPA-CO** will hold a **Pre-Bid Conference** on **October 20, 2022; 1:30pm** via **Zoom Application** with Meeting ID: **838 7890 7426** and Passcode: **BAC 2022** which shall be open to prospective bidders.
7. Bids must be duly received by the **BAC Secretariat** through **manual submission** at the **2/F Administrative Division, DOJ Agencies Bldg., NIA Road, East Avenue, Diliman, Quezon City** on or before **November 3, 2022; 1:00pm**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **November 3, 2022; 1:30pm** at the **3/F Multi-Purpose Hall, DOJ Agencies Bldg., NIA Road, East Avenue, Diliman, Quezon City**. Bids will be opened in the presence of the bidders' representative who choose to attend the activity.
