INVITATION TO BID

1. The PAROLE AND PROBATION ADMINISTRATION-CENTRAL OFFICE (PPA-CO), through the FY 2022 General Appropriations Act intends to apply the sum of Nine Million Four Hundred Six Thousand Eight Hundred Pesos (Php9,406,800.00) being the ABC to payments under the contract for "Supply, Delivery and Installation of ICT Software Subscription Requirements for the Security Licenses of the Parole and Probation Case Management Information System covering: Encrypted Communication Platform System, Remote Management and Monitoring System and Asset Management System" with Project ID No: PPA2 023-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **PPA-CO** now invites bids for the above Procurement Project. Delivery of the Goods is required within **one-hundred fifty (150) calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **PPA-CO BAC Secretariat** and inspect the Bidding Documents at the address given below during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on February 7-27, 2023 and upon payment of the non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (Php 25,000.00). The bidder must present its Official Receipt as proof of payment for the fees to be presented before the bid opening.

It may also be downloaded free of charge from PhilGEPS website provided that the bidder shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on February 27, 2022; 9:30AM at the 3/F Multi-Purpose Hall, DOJ Agencies Bldg., NIA Road, East Avenue, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representative who choose to attend the activity.
