## INVITATION TO BID

1. The PAROLE AND PROBATION ADMINISTRATION-CENTRAL OFFICE (PPA-CO), through the FY 2024 General Appropriations Act intends to apply the sum of Forty-Three Million Three Hundred Nine Thousand Seven Hundred Six Pesos (Php 43,309,706.00) being the ABC to payments under the contract for "Supply, Delivery, and Installation of Information and Communications Technology (ICT) Equipment for the Enhancement and Maintenance of Information Systems" with Project ID No: PPA2023-03. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The PPA-CO now invites bids for the above Procurement Project. Delivery of the Goods is required within sixty (60) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from PPA-CO BAC Secretariat and inspect the Bidding Documents at the address given below during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 26 - November 15, 2023 and upon payment of the non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (Php 25,000.00). The bidder must present its Official Receipt as proof of payment for the fees to be presented before the bid opening.
  - It may also be downloaded free of charge from PhilGEPS website provided that the bidder shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- The PPA-CO will hold a Pre-Bid Conference on November 3, 2023; 9:30AM via Zoom 6. Application with Meeting ID: 893 2148 1267 and Passcode: BAC2023 which shall be open to prospective bidders.
