Women Deprived of Liberty, Focus of the 29th Correctional Consciousness Week Celebration

"It has never been about drugs, it has always been about people."

For the celebration of the 29th National Correctional Consciousness Week, the Parole and Probation Administration put the spotlight on women deprived of liberty. The goal to understand their plight was evident in the theme "Empathy and Empowerment: Understanding the Pathways to Crime for Women Deprived of Liberty".

The Community Services Division (CSD) led by CPPO Danilo Capili organized the 2nd Community Corrections Summit on October 27, 2023 to fulfil this objective. The summit was dubbed "Unblocking Empathy, Empowering Exploring Change: the Journeys of Incarcerated Women". The CSD tapped Ms. Ma. Inez Feria of NoBox Philippines as the resource person. To optimize the opportunity, the summit was conducted via Zoom video conference. About 732 PPA officials and employees from around the country attended the webinar.

In her lecture, Ms. Feria emphasized that "it has never been about drugs; It has always been about people". She urged the participants to look into the human context of why people use drugs.



She ended the lecture by presenting the proposed framework for Reintegration: A New Perspective, which captures the present plight of women deprived of liberty as they reintegrate into society.

Another important aspect of National Correctional Consciousness Week is the emphasis on community engagement and participation in the rehabilitation progress. The goal is to encourage communities to take an active role in the rehabilitation and reintegration process of PDLs through community-led activities.

With the support of Local Government Units (LGUs) and other pillars of the criminal justice system, such as the Bureau of Jail Management and Penology (BJMP), the Regional Offices and Field Offices reached out to the clients through massive information drives, and paralegal services to PDLs.

Abbatuan, COS, PSED. # Working Tog<mark>ether toward</mark>s Jails and Prisons Decongestion

'The congestion of jails is not "merely a logistical or infrastructure problem, but rather a "profound human rights issue."'

The issue of jail decongestion has been a long-standing problem in the country. Solving the issue requires urgent and comprehensive solutions. In response, government, NGOs, and private sectors exerted efforts to improve the condition of jails and prisons in the Philippines but much is to be desired to realize a decongested jail. Then a new development within the justice sector happened. On December 6-7, 2023, the Justice Sector Coordinating Council (JSCC), in partnership with the European Union and Australian government through the Governance in Justice (GOJUST) and the United Nations Office on Drugs and Crime (UNODC) spearheaded the Conference to Unlock Solutions to Jail and Prison Overcrowding.

The conference aimed to discuss several potential solutions to the pressing issue and changes to be made within the justice sector. Administrator Bienvenido Ο. Jr himself attended Benitez, the conference. He was joined by CPPO Nancy B. Senoren, CPPO Virgilio B. Duldulao, CPPO Ma. Isabel B. Castillo, CPPO Amelita S. Basibas, SPPO Shiela Marie O. De Leoz, and SrPO John Carlo S. Voluntad.

Chief Justice Hon. Alexander G. Gesmundo opened the summit with his welcome remarks. Meanwhile, House Speaker Hon. Ferdinand Martin G. Romualdez, one of the guests of honors, discussed some proposed solutions to the persisting problem. During his presentation, House Speaker Romualdez pointed out that jail congestion is not "merely a logistical or infrastructure problem," but rather "a profound human rights issue."

He added that the condition of jails and prisons reflect the country's judicial processes, and on "the very essence of justice and humanity in our society." He proposed the creation of a single dedicated agency, like a Department of Corrections and Penology, which he said would drastically streamline the operations of prisons.

Plenary Session 1: Presentation of Jail Decongestion Study

Atty. Rommel Α. Abitria, Executive Director of Humanitarian the Legal Assistance Foundation, and Dr. Raymund E. Narag, an Associate Professor from Southern Illinois University presented their Socio-legal study the on Philippine Phenomenon of the Jail Overcrowding and Factors Contributing to Jail and Prison Overcrowding. They introduced the CITO Framework (Jail Capacity through Input, Throughput, and Output). According to them some of the many factors that contribute to jail congestion unlawful arrests, are prolonged preventive imprisonment, and limited alternatives for imprisonment.



Atty. Abitria and Dr. Narag proposed three (3) solutions to decongest our jails and prisons. First, decrease the intake of law offenders by decriminalizing some offenses, utilize the benefits of Alternative Dispute Resolutions, and modernize the Probation System. Second, integrate the correctional agencies (BJMP, Provincial Jails, BuCor, PPA, and BPP) and create regional prisons. Third, modernize and expand the parole system, and rationalize the use of GCTA.

Dr. Narag said that these mechanisms will rationalize the criminal justice system where limited jail and prison spaces will be reserved for the truly deserving. This will reduce the cost of running the facilities and will also increase public safety.

Plenary Session 2: Addressing Congestion Through Criminal Justice Reform in Brazil: Important Lessons from the Global South

JSSUPT Atty. Roy P. Valenzuela, Chief of Staff, Office of the Undersecretary for Public Safety, DILG, conducted a workshop regarding Examining Decongestion Programs, Alternative Dispute Resolution, and Potential Solutions for the Criminal Justice Systems.

According to Atty. Valenzuela, four aspects cause high PDL intake:

- Community aspect: Weak peacemaking culture
- Law Enforcement aspect: Arrest quota Culture
- Prosecution aspect: Insufficient case filtering mechanism
- Court aspect: Congested court dockets

Atty. Valenzuela proposed the following administrative and legislative remedies to address the jail congestion problem.

- Improve the Barangay Justice
- Establish a mandatory Judicial Determination of Probable Cause
- Mainstream and institutionalize Alternative Dispute Resolution

If fully utilized, the ADR will be a great solution to declog court dockets, he said.

Plenary Session 3: Input Reduction for Decongestion: Reviewing Law Enforcement and Prosecution Practices

Hon. Jesse Hermogenes T. Andres discussed some of the reforms made and/or to be made in our Criminal Justice System, according to him, there is a need to review and revise the Rules of Criminal Procedure (Preliminary Investigation), executive review of dangerous drugs act, and utilize the jail decongestion innovations such as the use of digitized Single Carpeta System.

Thereafter, Senior Assistant City Prosecutor, Aris S. Manguera, Department of Justice, conducted a workshop regarding Electronic Initiatives Inquest and for Speedy Disposition of Cases. His discussion focused on the importance and benefits of Electronic Inquest. According to Prosecutor Manguera, Electronic Inquest will reduce pre-trial detention and inquest resolution can be promulgated within the day. Prosecutor proposed the Pretrial Manguera also Diversion of Adult Offenders Through Prosecutorial Discretion which according to him will result in a lesser intake of PDLs to Correctional Facilities since prosecutors will have the power to decide whether to pursue or not criminal charges, especially to the first-time offenders.

Plenary Session 4: Output Increase for Decongestion Release Schemes, Planning and Current Policies

Undersecretary Raul T. Vasquez discussed the actions the Department of Justice has been taking to decongest jails and prisons. He spoke of the DOJ's initiatives such as the construction of regional prisons, lower bail amounts, release of PDLs through proper and timely evaluation by prison authorities, and proper legal representation of PDLs. Undersecretary Deo L. Marco supported the presentation of USec. Vasquez and talked about the importance and advantages of having regionalized penal farms.

The summit ended with the hope that all of the proposed strategies, plans and projects regarding jail and prison decongestion will materialize. #

CED'S JOURNEY: FROM STRUGGLE TO REDEMPTION

Ced's story is one of overcoming obstacles and finding gratitude in unexpected places. From a troubled past to a bright future, his journey reflects the power of second chances and personal growth. At 22, he was convicted of Rape which he admittedly did. Remorseful, he learned a great life lesson and is now eager to better himself and swore to start anew.

After he was charged, Ced felt stuck, unable to continue to pursue his goals and dreams in life. Initially, he was skeptical about those in jail. However, his perspective changed during his month and a half in prison. There, he faced limitations that pushed him to reflect on his life. Upon, release, probation became his second chance. He decided to make the most of it, embracing education and taking side hustles as an assistant electrician of his father while helping with the household chores. The start of probation brought challenges, but he became more aware of his actions. Balancing school, work, and family responsibilities, he illustrates a well-rounded approach to personal development.

His lessons include the importance of family and open communication. Grateful of God's grace, he also gives thanks to his fellow prisoners for support, friends for not judging, and the probation office for the opportunity that give him a chance to prove his worth as a person. Currently in grade 12, he dreams of completing his studies in senior high school, enrolling in an Electrical Engineering degree, becoming а breadwinner for his family, and inspiring others. He advises fellow probationers to be grateful for their second chance and prove themselves through actions: "Maging thankful tayo na talagang pinagbigyan tayo kahit pa gaano kabigat ang naging kaso natin. Maging thankful tayo sa office, sa mga officers natin, na nabigyan tayo ng chance na ganito - na labas makalaya [at] nasa tavo. makatrabaho para sa pamilya natin. At maging thankful din na nakapag-aaral tayo sa labas kaysa sa loob tayo [ng kulungan nag-aaral] at maraming bagay [opportunities] na di natin ma-eexperience sa loob [kulungan]."

His journey is a story of transformation moving from a challenging past to a hopeful future. His resilience, gratitude, and pursuit of personal greatness during probation serve as an inspiration to anyone facing similar struggles. #

"Laura" was close to losing her faith. Because of drug charges, she has already spent two years in one of the cramped jails in Metro Manila, and the days and weeks are blending into each other, day in, day out.

She lost all contact with her family, and all her so-called friends did not even bother to visit her. She finally had a visitor, but he is a bearer of bad news that her father passed away. She was granted permission to pay her respect on the last night of his wake, but the handcuffs on her wrists and the presence of her armed guards made the experience a very painful one. Everyone in the wake avoided her like plague.

At that time, she thought she will languish in prison for 12 years as it seems that her application for probation would never be approved. But in the middle of all that darkness and loneliness, she asked for strength from her late father. And she held on to her faith.

God seemed to answer her prayers when she was released through probation.

There was a catch, however, when she was forced to move out of Metro Manila as her family does not want her there. But as she looked back at her years in prison, she took the experience as God's wake up call.

She nearly lost hope but she realized that God gave her a second chance through probation and it should not be wasted. With new hope and profound thankfulness that her aunts gave her a place to stay in Naga City, Laura made good on her plans to change. She looked for a job and she made ends meet to help herself and her family whose relationship she was able to restore. Looking back, she realized that if she was not asked to move out of Metro Manila, most likely she would be back in jail, just like her friends. It was a blessing in deep disguise.

In due time, Laura was given another shot at love. A few months after she reported at the probation office, she met another probationer. They started living together in 2021. Someday, she would want to be remembered by her grandchildren as someone who made some wrong decisions in life but was redeemed through probation. She would want them to learn so that they would not go down the same path she did.

She began to believe that God's gifts of faith, hope and love were not limited to "good" people. She realized that God extends his hands most especially to those who are in the dark, like a Good Shepherd seeking out lost sheep.

Shortly before Christmas of 2023, she received a fourth gift, her court order that her probation period has been terminated, making her truly free. Indeed, probation can be a way of "redeeming lives, restoring relationships".

One only needs to realize the mysterious ways that God is at work in one's life. #



FEAR (FORGET EVERYTHING AND RUN) OR FEAR (FACE EVERYTHING AND RISE)

Committing a crime and escaping the law are two of the toughest and scariest things that "Kuya Joel" did. It felt like playing an unending game of hide-and-seek and running for the rest of his life. He could not be happy or at ease. Physically free but his mind was already imprisoned with thoughts of "what-ifs" that troubles him repeatedly, It is true that we cannot always run from our problems forever. It will always come back to haunt us and we will ultimately be forced to pay the price of our actions.

It is ironic, then, that he is grateful for his experiences, specifically the instance which led to his conviction and his detention at a correctional facility. Adversity helped him became resilient over the face of difficult situations and became reconnected to God when everything and everyone else turned away from him.

Kuya Joel used to be a manager in a wellknown restaurant in Camarines Norte. Out of desperation to help his partner buy medicines for his ailing father, he outsourced money in the wrong way which led to his conviction. He was sued, but he managed to get away from the law and moved to a place where no one knew him. His partner, whom he loved the most, committed suicide after learning of his conviction. This added to his already intense anguish and loneliness. He questioned why God was doing this to him but he also prayed to help him find the answers to all his questions.

As the days passed, he gradually came to understand and repent from the mistakes he made. He knew that God moved, clearing his mind, worries, and anxiety. He finally chose courage over comfort. Even with shaking knees and fearful heart, he surrendered himself to the authorities after a year of evading the law. Even though it meant that his freedom would be in jeopardy, he was at last, letting go of the baggage that was hurting and haunting his mind, heart, and soul. It has been a long time since he felt that kind of relief and peace of mind.

He is still thinking how underserving he is of the second chance he has. His family, job, and freedom are all God's Grace. Through the sharp twists and turns he has experienced, he learned life-changing lessons : 1) escaping the law does not necessarily equate to true freedom; 2) avoiding problems or evading responsibilities does not lead to lasting peace of happiness; 3) confronting one's actions, taking responsibility, and seeking ways to make amends are crucial steps toward personal growth and healing; 4) surrendering and reaching out to God and other people for assistance is a sign of strength rather than weakness; and ultimately, 5. Nothing is impossible with God and to people who are willing to give him another try, another chance, and another life. #
