PPA Builds Partnerships Toward Sustainable Rehabilitation Efforts



The PPA started the year with zeal forging partnerships up to the middle of 2024. Through Administrator Bienvenido O. Benitez, Jr., PPA signed several important agreements. These collaborations created sustainable programs that help the clients to live a second chance at life.

On January 10, Administrator Benitez flew to Victorias City for a government-togovernment cooperation that would benefit 148 clients. Livelihood programs, entrepreneurship opportunities, skills training, and capacity-building await the recipients. Signatories to the MOA conveyed their support for the collaborative program.

Mayor Javier Miguel Benitez congratulated the program beneficiaries and partners. He said, "Everybody gets the second chance that everybody deserves".

The next month, PPA and Share an Opportunity Philippines, Inc. (SAOph) inked an agreement on February 27, 2024, at Teodulo Natividad Hall in the Central Office. The venture would help the field officers in uplifting the welfare of clients. Under this MOA, clients of the three Quezon City field offices would receive help.

Clients and their families could benefit from SAOph's programs. These are the Makabata Program, Communities Adapt, and the Resource and Services Development Program.

The **Makabata Program** aims to help create an environment fit for children and families. It is a community-based approach to caring for children. **Communities Adapt**, on the other hand, aspires to build community resilience against disasters and reduce vulnerabilities to climate change. With the **Resource and Services Development Program**, SAOph holds outreach and livelihood programs through community-based organizations.

Before the quarter ended, Subic Bay Metropolitan Authority became PPA's partner in the Workplace Reintegration Program (WRP). 158 possible beneficiaries could take advantage of this Program which would be jointly monitored and evaluated by SBMA and PPA.

SBMA Senior Deputy Administrator for Support Services Ramon O. Agregado said, "For our part, we will facilitate the endorsement of potential and qualified clients through a Register of Eligibles (ROE) to Subic Bay Freeport Zone locator-companies under the Workplace Reintegration Program".

Administrator Benitez hoped more companies would follow suit.

Chairman and Administrator of SBMA Eduardo Jose C. Aliňo and Atty. Bienvenido O. Benitez, Jr. sealed the deal on April 11, 2024 at the SBMA Corporate Boardroom. Joining them were Regional Director Marissa D.C. Alquetra and Atty. Ramon O. Agregado.

For clients with skills in line with agriculture and fisheries, the Agency teamed up with the Agricultural Training Institute (ATI), a government bureau under the Department of Agriculture.



Atty. Bienvenido O. Benitez, Jr. and Director IV Remelyn R. Recoter set their hands on the Memorandum of Agreement during the Pistang Ani ng Bayan celebration on May 31, 2024. The MOA signing ceremony held at the ATI Building in Quezon City became one of the event's highlights.

Accordingly, PPA and ATI would work hand in hand in equipping probationers and parolees with agriculture and fisheries-related training. Eligible clients could also receive material support. Should they form an entity composed of 20-30 persons, ATI could also provide them with funding.



Meanwhile, the meeting on long-term collaborations with the Office for Alternative Dispute Resolution was set last May 22. The conference centered on holding specialized training on mediation-conciliation, a topic relevant to RJ practitioners and grievance committees as key persons in resolving conflicts. The said training would focus on enhancing the skills of these personnel.

Then on July 5, 2024, Administrator Bienvenido O. Benitez, Jr. and Undersecretary Irene De Torres Alogoc finally signed the Memorandum of Understanding at the Multi-purpose Hall in the PPA-Central Office.

Completing the Memorandum of Understanding, the OADR held the training on August 12-16, 2024, at the OADR Academy in Quezon City. The training enhanced the mediation skills of RJ practitioners and marked significant progress for Philippine Alternative Dispute Resolution.

Last year, the Administrator sealed four agreements of a national scope. These were undertakings with BJMP, TESDA, UNODC, and DOLE.

These partnerships with government institutions and NGOs are a resource generation effort that boosts the Agency's capability to deliver services and achieve its mandate.

The probationers, parolees, and pardonees as recipients of these services can live a decent life, and be productive citizens away from a life of crime. At the same time, the probation officers guide the clients toward successful rehabilitation and reintegration into society. All these endeavors contribute to keeping peace and social justice in the community. ### /majrb

PPA's New Investigation and Supervision Program Strengthens Commitment to the Tokyo Rules



The Administration officially launched the new investigation and supervision program. This was in partnership with the United Nations Office on Drugs and Crime (UNODC). The launch was held on August 5-7, 2024, at the Crowne Plaza Hotel in Ortigas, Pasig City.

The new program, the **Principles of Effective Probation and Parole Investigation and Supervision** includes four tools such as the following:

- Classification and Risk Assessment Tool (CARAT)
- Hulagpos
- I-CARE; and
- Livelihood and Education Access Program (LEAP)

According to CPPO Danilo Capili, UNODC Alternate Focal Person, this Program reinforces PPA's commitment to the Tokyo Rules. The Tokyo Rules, also known as the United Nations Standard Minimum Rules for Non-custodial Measures states the basic standards that should be present in the use of community-based or out-of-prison treatment of offenders.

He explained that the integration of offenders into society should be in a way that lowers the likelihood of a return to crime. The rehabilitation of offenders, he said, should be within the principle of minimum intervention, which the Program addresses.

Using the CARAT, the needs of clients are determined through a series of carefully crafted questions, and the right treatment approach is identified. Based on their answers, they may undergo Hulagpos, or receive I-CARE or LEAP.

The use of the Program is promising, said CPPO Capili. Findings presented by Dr. Raymund E. Narag, a UNODC consultant, showed that 60% of clients don't need any treatment at all. With the effort, resources, and time focused on the 40% who need it, probation officers become more effective and efficient in their jobs.

By 2026 the Program will roll out nationwide as planned. But to make sure that the tools are reliable and valid, the PEPPIS is expanded to all regions in the country from the few selected pilot sites. Administrator Bienvenido O. Benitez, Jr. issued Memorandum Order No. 29, series of 2024 directing all heads of the regional offices to nominate additional pilot sites. For regions without pilot sites, the regional head may nominate at least three field offices up to 50% of the field offices. Meanwhile, for regions with pilot sites, the regional head may either nominate 50% or include all its field offices. This is crucial to collecting more data for validating the Investigation and Supervision Program. ### /majrb

On August 27, 2024, the Department of Justice and its attached agencies' regional heads guested on the program. It was aired via Radyo ng Bayan and streamed on PIA's social media pages.

Aside from the Parole and Probation Administration, other government bureaus joined the series. These are the National Prosecution Service, the Bureau of Immigration, LRA, NBI, and the Public Attorney's Office.

The coordinated simulcast aligned with the President's directive to inform the public of the government's programs and projects at the grassroots level.

The PPA through the Regional Directors and Regional Officers-in-Charge presented the ongoing programs, activities, and achievements specific to their regions.

Some important topics they discussed were PPA's role in decongesting jails and preserving peace and public safety, the multipronged approach to rehabilitating clients that utilizes the Therapeutic Community Ladderized Program, Restorative Justice, and Volunteer Probation Assistants.

Kapihan provided the opportunity for the regional heads to shed light on the process of investigating petitioners for probation or parole. Probation officers thoroughly investigate before submitting the result to the courts or the Board of Pardons and Parole (BPP). They verify their legal qualifications and suitability - if they fit the community. The courts or the BPP then grant or deny the requests of the petitioners.

The Agency's digitalization and modernization efforts were also discussed. CMIS or Case Management Information System and PMEIS or Performance Monitoring and Evaluation System were tackled. Other modalities such as the Livelihood and Education Access Program (LEAP), Hulagpos, and iCARE under the Principles of Effective Probation and Parole Investigation and Supervision (PEPPIS) were likewise explained. These tools would further improve and modernize the individualized treatment of clients.

An effort on a national scale started this synchronized activity. In July, Administrator Bienvenido O. Benitez, Jr. joined the launching of the DOJ Town Hall Meet. The Meet featured the Katarungan Caravan in Dasmariñas, Cavite. Justice Secretary Jesus Crispin Remulla and the Undersecretaries led the event.

Gearing up for Compliance: Central Office Submits to Several Audits

In the past months, the Central Office has undergone several audits by oversight agencies such as the Anti-Red Tape Authority (ARTA) and Internal Audit Service (IAS) of the Department of Justice. The purpose was to check the Agency's compliance with laws and regulations, the performance of operating and support services, and conformance to identified standards.

Apart from the QMS Internal Quality Audit, the Central Office was also assessed by the IAS. The evaluation was scheduled randomly from July 1 to September 16, 2024. Internal Auditor IV Eva Mempin, Internal Auditor III Grace Asuncion Nolong, and Internal Auditor I Jonell Detablan conducted the face-to-face inspection and interview.

Like the QMS audit, the IAS began with an opening meeting with the Administrator and Division Chiefs. The on-site visit of offices and units followed after that. After several days, the DOJ-IAS started the formal assessment by requiring the submission of documentary evidence. The Central Office was given one week to comply. The auditors reviewed these documents before notifying the Administration of their inperson interview. For more than a week, the IAS verified the Agency's compliance with laws, personnel and structure, planning, efficiency of operations, and performance of units.



After over a week, the auditors returned for the closing meeting on September 25, 2024. During the meeting, Internal Audit Service Director IV Arnold Joseph Co and the three auditors presented the result of their evaluation. The IAS noted five Audit Observation Bulletins (AOB). Once these AOBs are addressed, PPA's internal control system and conformance to the identified standards would be strengthened even more.

Meanwhile, the Anti-Red Tape Authority visited the Central Office on September 11, 2024, for an ocular inspection. Ms. Ma. Christine B. Camata, and Ms. Jeanette C. Sanson from ARTA checked the Agency's compliance with the provisions of Republic Act 11032 also known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018. The auditors went to the Case Management and Records Division and the Technical Services Division.

Based on their monitoring checklist, PPA complied with all the reportorial requirements. However, for the Information Billboard and Handbook compliance, ARTA listed three recommendations or required actions. In the end, ARTA recognized the Agency's four good practices. These are wearing the ARTA ID, nameplates on desks, use of the Harmonized Client Satisfaction Survey Form, and one signatory on certificates. ###
